- VABB: AIP Supplement 136/2019: Closure of RWY 09/27 for re-carpeting works from 0400-1200 UTC.
- VECC: RWY 19L/01R Not available for operations due scheduled maintenance work from 1900 2300 UTC when VIS 1200M or Above, During this period RWY 19R/01L available for Acft operations. (Refer **NOTAM # A1887/19)**
